# Purpose and Background

- In 2022, Commerce was awarded funding from the US Department of Justice under the Byrne State Crisis Intervention Program (SCIP)
- Funding will improve implementation of state laws that can result in firearm relinquishment
- Pursuant to
  - Extreme Risk Protection Orders (ERPOs)
  - Orders to Surrender and Prohibit Weapons (OTSPWs)
  - Other Civil Protection Orders

 Soliciting proposals with expertise in research, data collection, analysis and presentation, evaluation of processes and outcomes

# Objectives

Funded projects and the resulting recommendations will help policymakers, and system and community partners, improve the effectiveness of implementation and enforcement of the state's firearm relinquishment laws. This NOFO is intended to complement COMMERCE's other SCIP-funded projects to collectively improve the implementation and enforcement of the state's firearm relinquishment laws.

# Scope of Work

- Proposals should cover ONE of these project areas:
  - Project Area 1: Data collection and Analysis
     OR
  - Project Area 2: Dashboard Design and Implementation
     OR
  - Project Area 3: Data-Sharing
     OR
  - Project Area 4: Support for and Coordination with Tribal Partners
- Interested in more than one project area? Submit separate proposals.
- Commerce will award ONE contract for each project area.

# Scope of Work (cont.)

### Proposals should address

- Data elements, data sources, data collection strategies, data challenges
- Methods for data quality, confidentiality
- Additional research to be conducted
- Work with system partners on data conclusions and recommendations
- Data-sharing agreements
- Data analysis and alignment
- Strategy and timeline of final outcomes

# Scope of Work (cont.)

### Proposals should result in recommendations for

- Steps to implement and enforce WA firearm relinquishment laws;
- Additional types of data to be collected;
- Measures to increase cross-jurisdictional data availability and comparability;
- Ways to synthesize data;
- Steps to make existing data more complete, accessible and accurate; **OR**
- Tools, technologies, or databased to improve real-time, consistent and comprehensive tracking of data and orders.

# Minimum Qualifications

- Expertise in gun violence research, related social or health research, and/or public entity research experience in data collection, program evaluation, and analysis as demonstrated by projects led by and/or participated in by Proposer
- Licensed to do business in the state of Washington or submit a statement of commitment that it will become
  licensed in Washington within thirty (30) calendar days of being selected

Given the need to expand and diversify the pool of researchers studying firearm-related issues in our state, and COMMERCE's commitment to diversity and equity, COMMERCE encourages projects that are proposed by multi-institution or multi-disciplinary teams (for example, public health, medical, public policy and criminology researchers), which include researchers who have not previously received funding from COMMERCE, or projects led by or with key roles for researchers of color, women, and/or impacted individuals. Although addressing each of these priorities is not required for all Proposals, Proposals that address any or all of these concepts are strongly encouraged by COMMERCE.

# Funding

- COMMERCE intends to award multiple contracts (one contract per project area)
- COMMERCE has budgeted an amount not to exceed \$938,603 for this total project
- Individual Proposals may not exceed \$250,000
- Proposers interested in submitting for more than one project area should submit separate Proposals for each project area and may not exceed \$250,000 per project Proposal
- Proposals in excess of \$250,000 will be considered non-responsive and will not be evaluated

As part of funding decisions, COMMERCE will also consider applicants' history of performance, failure to meet deadlines, spending, and compliance with requirements from previous and current contracts with COMMERCE.

# Proposal Content: Cost Proposal

- Do not exceed \$250,000
- Designed to award to the Proposal that best meets the requirements (not necessarily least cost)
- Identify all costs including expenses to perform the service necessary to accomplish the objectives
- Upload/Submit a detailed budget using the template provide in ZoomGrants

# **Proposal Evaluation**

- Technical Proposal 80%
  - Project Approach/Methodology
  - Work Plan
  - Project Schedule
  - Outcome and Performance Measurement
  - Risks
  - Deliverables
- Management Proposal 20%
  - Project Management (Team Structure, Internal Controls, Staff Qualifications)
  - Experience of the Proposer
- Cost Proposal Extra Points Possible
- Workers' Rights Certification Extra Points Possible

### 2.6 SUBMISSION OF PROPOSALS

The proposal must be received by the NOFO Coordinator via ZoomGrants no later than 11:59 pm PT, on Sunday, April 28, 2024.
